**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MABTON, WASHINGTON, INTENT TO ANNEX**

**WHEREAS**, a Petition for Annexation was filed by John and Sandy Birdlebough and the City of Mabton on May 10, 2016, proposing the following described property be annexed to the City of Mabton:

**WHEREAS**, the City of Mabton has determined that, subject to approval by the Yakima County Boundary Review Board, such annexation should be made and such annexation should be known as the Birdlebough Annexation;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council for the City of Mabton, Washington, as follows:

**Section 1.** The above described properties should be annexed to the City of Mabton and subject to approval by the Yakima County Boundary Review Board, to be effective upon passage and the effective date of an Ordinance approving the same, condition upon said property being assessed and taxed at the same rate and on the same basis as other property within the City of Mabton.
