

ORDINANCE NO. 2020-1160

AN ORDINANCE AMENDING ORDINANCE NO. 2016-1074 OF THE CITY OF  
MABTON, WASHINGTON, AMENDING AND SETTING USER FEES AND CHARGES

**WHEREAS**, City Council is responsible for establishing and reviewing user fees and charges and has made such determinations on a periodic basis with such fees and charges set forth in separate ordinance provisions; and

**WHEREAS**, City Council has determined that it is more efficient to consolidate its fees and charges into a single user fee/charge ordinance to be reviewed periodically by the City Council; and

**WHEREAS**, City Council has reviewed such user fees and charges and determined that certain revisions are reasonable and appropriate.




**SECTION 1.** User Fees and Charges are amended as more specifically set forth on the attached Master Fee Schedule which is incorporated by this reference.


