AN ORDINANCE AMENDING ORDINANCE 2014-1032 WHICH AMENDED THE 2014 BUDGET FOR THE CITY OF MABTON, WASHINGTON, FOR THE FISCAL YEAR ENDING DECEMBER 31, 2014 FOR THE FOLLOWING FUNDS 001-GENERAL FUND REVENUES & EXPENDITURES, 102 CEMETERY FUND REVENUE, 103 STREET FUND REVENUE & EXPENDITURES, 108 CDBG REVENUE & EXPENDITURES 115- EMS FUND REVENUE & EXPENDITURES, 401 WATER FUND REVENUE & EXPENDITURES, 402 SEWER FUND REVENUE & EXPENDITURES, 404 GARBAGE FUND REVENUE & EXPENDITURES, 405 WATER/SEWER RESERVE REVENUE & EXPENDITURES , 418 89 BOND RESERVE REVENUE & EXPENDITURES, 601 CEMETERY PERRUTAL CARE

BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF MABTON, WASHINGTON AS FOLLOWS:

Section 1. Purpose of Ordinance: The City Council for the City of Mabton, Washington has determined that it is in the best interest of the City to amend the 2014 budget for the following funds: **REVENUE FUNDS: 103 STREET FUND, 401 WATER FUND, 402 SEWER FUND, 404 GABAGE FUND & EXPENDITURE FUNDS: 001 GENERAL FUND, 401 WATER FUND, 402 SEWER FUND**
