

ORDINANCE NO. 1049-2015

**AN ORDINANCE OF THE CITY OF MABTON, WASHINGTON, AMENDING
ORDINANCE NO. 1040-2014 INCREASING THE WATER RATES BY \$6.00 IN THE
CITY OF MABTON EFFECTIVE JANUARY 20, 2015.**

WHEREAS, THE CITY COUNCIL OF THE CITY OF MABTON REVIEWED RESIDENTIAL WATER RATES FOR THE CITY OF MABTON FOR YEAR 2015; AND

WHEREAS, IT IS DETERMINED THAT RATES WOULD BE RAISED BY \$6.00;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MABTON, WASHINGTON, AS FOLLOWS:

SECTION 1. THE CITY OF MABTON OFFERS REDUCED WATER,SEWER AND GARBAGE RATES FOR QUALIFING, SINGLE FAMILY RESIDENTIAL CUSTOMERS WHO ARE 62 YEARS OR OLDER,OR DISABLED. TO QUAILFY, YOU MUST BRING A COPY OF YOUR CURRENT DRIVERS LICENSE OR I.D. AND/OR A COPY OF YOUR SPOUSES, AND FILL OUT THE SENIOR APPLICATION AT CITY HALL.


