

ORDINANCE NO. 2015-1054

AN ORDINANCE AMENDING ORDINANCE NO. 2014-1048 SETTING WAGES FOR OFFICERS AND CITY PERSONNEL TO BE EFFECTIVE AS OF JUNE 9, 2015 WASHINGTON, AS FOLLOWS:

BE IT ORDAINED, BY THE CITY COUNCIL FOR THE CITY OF MABTON, WASHINGTON, AS FOLLOWS:

Section 1. Statement of Purpose: The City has set wages for officers and city personnel to be effective June 9th, 2015 and is set forth herein below:

Wastewater operator I	\$ 20.15 hour
Public Works WDM II	\$20.33 hour
Public Works I	\$15.75 hour
Public Works Temp	\$12.00 hour (4months)
Police Chief	\$4,900 per month
Acting Chief	\$25.75 hour
Sergeant	\$23.41 hour
Police Officer	\$18.00 hour
Police Reserve	\$16.00 hour
Police Tech	\$15.00 hour
Police Admin I	\$ 14.76 hour
Volunteer Fire Chief	\$500.00 per month

Section 3. Reserve Officers: Reserve Officers will work (16) sixteen hours each month before the wage rate of \$16.00 per hour will occur, not to exceed 68 hours each month. Any hours worked over the 68 hours will be on Reserve Status. It will be at the discretion of the Police Chief as to who will be scheduled for these hours, as well as closely monitor the schedule to keep within the budgeted amount.

Section 4. Severability: If any provision of this Ordinance or its application to any person or circumstances is held to be invalid the remainder of this ordinance

Section 4. Severability: If any provision of this Ordinance or its application to any person or circumstances is held to be invalid the remainder of this ordinance or application of the provision to other persons or circumstances, shall not be affected.

Section 5. Effect: This Ordinance shall become effective (5) five days from and after its publication as provided by law.
