

ORDINANCE NO. 2016- 1090

**AN ORDINANCE CLOSING FUNDS 412, 414 AND 418 AND ESTABLISHING FUND 602, 603 AND 605.**

WHEREAS, City of Mabton created and has maintained special funds designated as (1) 89 Bond Reserve Fund 412; (2) 98 Bond Reserve Fund 414; and (3) 89 Bond Redemption Fund 418. All activity related to the bond and project obligations is now complete; and

WHEREAS, City Council further finds that it is reasonable and appropriate to establish the following special funds: (1) Municipal Court Fund 602; (2) Park Project Donation Fund 605; and (3) Transportation Benefit District Fund 603; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MABTON DO ORDAIN AS FOLLOWS:

1. *Purpose.* The purpose of this Ordinance is to eliminate existing special funds that were created to account for project and bond funding which is now complete. An additional purpose is to establish special funds for accounting for municipal court funds, revenues and expenses for Mabton Transportation Benefit District and donations for the park improvement project.

2. *Repealer.* The following are hereby repealed:

- A. Ordinance No. 476 ;
- B. Ordinance No. 675 ;
- C. Ordinance No. 693 & 802

3. *Creation of Special Funds – Reversion.* The following special purpose funds are hereby established:


- A. Municipal Court Fund (#602);
- B. Mabton Transportation Benefit District (#603);
- C. Park Project Donation Fund (#605).

4. *Effective Date.* This Ordinance shall take effect the <sup>14<sup>th</sup></sup> day of <sup>December</sup> ~~January~~, 201<sup>6</sup>.


5. *Savings Clause.* Ordinance Nos. 476, 675 <sup>693</sup> and 802, which are repealed by this Ordinance, shall remain in force and effect until the effective date of this Ordinance.

6. *Severability.* If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance is declared unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining parts of this Ordinance.
